#### INTRODUCTION


This year was not much different than the previous year in that we were again affected by the retirement of two ranking officers. Detective Sergeant David E. Steffen and Corporal Mark V. Burchfield left the Department with a combined 60 years of service. Their retirements created the need for two promotions, two re-assignments, and two officers hired.

The Department received \$34,191.31 from the Richard "Dick" and Phyllis Ehrhart estate. The Northern York County Regional Police Board of Commissioners utilized the funds to upgrade the training facility at the Department Range Building. The new Dick and Phyllis Ehrhart Regional Training Center will be used to host training for agencies throughout South Central Pennsylvania.

This year, our Department continued to provide services to eight municipalities, the Townships of Dover, Manchester, Paradise, Conewago, Franklin, and Jackson and the Boroughs of Dover and North York. As well as Spring Grove School District.

The governing body (the Commission) is comprised of one elected official from each municipality. As such, Mr. Duane Hull represented Dover Township; Mr. Richard Pope represented Dover Borough; Ms. Michele Schanbacher represented Manchester Township; Mr. Lance Biesecker represented Paradise Township; Ms. Lois Leonard represented Conewago Township; Mr. Kenneth Staab represented North York Borough; Mr. Edward Campbell represented Franklin Township; Mr. Stephen Tansey represented Jackson Township. Mr. Joseph Rudolf from Reed Smith LLP in Philadelphia, PA represented our Department and Commission as solicitor. Kochenour, Earnest, Smyser, and Burg conducted an audit of our financial records.

These eight municipalities together encompass 145 square miles or 15.9% of the total landmass for York County. In accordance with generally accepted population figures, service is provided to about 66,608 citizens. The population, by municipality, is Dover Township -21,078, Dover Borough - 2,007, Manchester Township - 18,161, Paradise Township - 3,766, Conewago Township - 7,510, North York Borough -1,914, Franklin Township - 4,678, and Jackson Township - 7,494.



#### STAFFING

#### Units of Service

In keeping with the dictates of the "Articles of Agreement", municipalities purchase time by using a "unit of service" concept. Units are currently measured by a formula of 10 hours equaling one unit. Time is monitored in fifteen-minute increments on a daily, weekly and annual basis. This year, the Department managed 101,920 hours of service--100,360 hours of service to the municipalities and an additional 1,560 hours contracted to Spring Grove School District. These hours are specifically earmarked to/for our school resource officer's efforts in Spring Grove Schools.



In addition to the unit time, another 1305.63 hours of overtime was worked throughout the year. This was 195.63 hours more than last year. This overtime information is depicted on Chart I.

Also, several other overtime duty details—DUI checkpoints, Drug Task Force operations, United States Marshal's Fugitive Task Force, South Central Terrorism Task Force and private duty details—were completed for a total reimbursement of \$50,068.46/651.50 hours. This time is in addition to, but not included in, Chart I.

Twenty-five (25) members of the Department missed no sick time during 2011. Among these would be Lts Lash and Wasilko, Sqts Anderson, Gearhart, Migatulski and Neidigh, Cpls Asper and Kulak, Officers Baker Becker, Biesecker, Brininger, Eiker, Emenheiser, Godfrey, Groff, Hopta, Miller, Morley, Pague, Reimers, Ryman, Wallace and Ms. Mummert along with myself. Many of these members have not missed a day in years. The sworn members missed an average of one day this year which is the same as 2010. The non-sworn member average was 4.47 days compared to 3.09 days during 2010. Five sworn members were on leave for surgeries and were not calculated in the average.

During the year, one (1) workers compensation claim occurred. The claim involved the vehicle accident of Officer Groff. This is five less claims than submitted in 2010. The Department established a Safety Committee in 2010 to review duty-related injuries, discuss ways to prevent injuries, and improve the overall safety of employees while working.

The Department and its members received 92 commendations this year, equating to 26 more than 2010. Fifty-eight commendations recognized individual officers or groups of officers and 34 commendations recognized the Department. The Officers and the Department were commended for a job well done by:

We are very proud of this recognition by our peers and the public. The Chief and the Board of Commissioners recognized another 33 officers for their work in 2011. Officer Isaiah Emenheiser was named the Department's Officer of the Year. Nine officers were recognized for their efforts at a barricaded gunman incident and another 13 for their involvement at a shooting incident.

Three citizens, Deb Smith, and Mike and Betty Feldblum were recognized by the Board of Commissioners for their community service and assistance to our Community Policing efforts.

The Department investigated two conduct complaints that resulted in officers being suspended without compensation. Twelve other infractions occurred and were investigated that resulted in discipline less than a suspension. In this area, we will focus our efforts on improvement without sacrificing accountability.

## FIELD SERVICES DIVISION Patrol Section

#### Calls for Service

In order to understand the workload demands placed on the Department, it is important to have a historical perspective. In other words, where have we come from and where might we be going. To that end, we offer the following ten-year recap of activities. Our base year for this purpose is 2002.

This year our call load showed an increase of 4.91%. In 2011, we serviced 28,145 calls for police assistance, which are 1,318 more calls than the previous year. 2011 was the busiest year in the Department's 39 year history.

Therefore, our ten-year annualized average increase is 26.79%, which is a yearly average increase of 2.67%. A four-year review of this information is depicted on Chart II.

At this point, we will discuss, in some detail, the 28,145 calls serviced. As you review this information, it might be beneficial to understand how authorities look at police activity. "Experts report (and authorities generally agree) that of all the calls received for police assistance, approximately 20% will be "Criminal" in nature and 80% will be "Service" in nature". Our figures indicate that 13.97% (3,933) of our total calls (28,145) were criminal in nature and 86.03% (24,212) were service in nature. Therefore, we appear to be experiencing a less than average amount of criminality and a higher than average amount of service activity in our jurisdiction when compared to the norm.

<sup>\*\*</sup>The decrease in total calls from 2003 to 2004 results from the withdraw of Dillsburg Borough. However, participating members collectively experienced an increase.

A breakdown of our total activity has been charted in five general areas. Calls that are criminal in nature, as defined by the Uniform Crime Report, are a combination of 1,225 Part I offenses and 2,708 Part II offenses. Calls that are service in nature are a combination of 1,757 traffic accidents investigated, 267 ordinance violations and 22,188 incidents that have not been classified as criminal in nature and may best be described as service calls.

#### Activity

The Field Services Division, Patrol Section, issued 10,342 traffic citations this year. This is a decrease of 260 compared to 2010. For historical reference, our traffic enforcement index has, in the past years, moved both higher and lower.

The Board should know that the enforcement index is determined by dividing the number of injury/fatal accidents into the number of citations issued. An optimum enforcement index is 10-20 citations for every injury accident according to authorities in the field. A five year overview is as follows:

In addition to the 10,342 citations, officers issued 3,235 written warnings, up from 2,799 last year, 1,694 faulty equipment cards, which is up from the 1,456 issued in 2010, 556 parking tickets, down from 778 last year and 1,298 non-traffic citations, down from 1,526 last year. Also, 51 abandoned vehicle notices were issued along with 100 parking warnings. Therefore, patrol conducted no less than 15,978 traffic-related investigations in 2011 or more than 43 per day, on average, or almost 1.80 each hour of every day. None of this activity is classified as a reportable case and, therefore, is not tallied in the call-load figures expressed elsewhere on this report. Again, the Board should understand that this is self-initiated activity and not counted as a call or calls.

The average Patrol Officer did the following during the year:

- Responds to 744 incidents
- Responds to 58 traffic accidents
- Arrests 32 felons and misdemeants
- Arrests 47 summary criminal violators
- Contacts 536 traffic violators
- Drives 14,280 miles on patrol

In 2011, 472 persons were charged with "Driving Under the Influence" (DUI), which increased from 394 DUIs effected in 2010. Northern York County Regional Police officers continue to arrest intoxicated drivers at a far greater rate than their counterparts across the state. A ten-year recap illustrates the efforts made to keep our citizens safe.

During this period, we have arrested 3,299 persons for DUI or an average of 329.9 per year. Officers Isaiah Emenheiser, Michael Hine, and Patrick Gartrell were recognized by the Pennsylvania DUI Association for their outstanding efforts in 2011.

There were 65 drunk drivers involved in motor vehicle accidents, which reflects 13.77% of the total drivers charged with DUI. Of the 472 people arrested, 334 or 70.76% were male and 138 or 29.24% were female. Those arrested for DUI, on average, had a blood alcohol concentration of .16% or two times the legal limit. The highest blood alcohol reported in 2011 was .390% or 4.875 times the legal limit.

There were 26 DUI offenders who were under the age of 21. This accounted for 5.51% of the total.

DUI arrests, where drugs are the cause of intoxication, are classified by the higher UCR value attached to drug usage. During 2011, twenty-five (25) "Drivers Under the Influence" were found to be under the influence of drugs and, therefore, charged with DUI/Drugs and, as a result, removed from the population of traditional "Drivers Under the Influence" for accurate reporting.

#### Overall Criminal Activity





#### Serious Crime

The 1,225 reported crimes classified as Part I Offenses under the FBI Uniform Crime Report System are the most serious crimes. Serious crime was up 9.22% (96 incidents) in our entire jurisdiction. Part I crimes include: Homicide, Manslaughter, Rape, Robbery, Aggravated Assault, Burglary, Theft, Auto Theft and Arson. Serious crimes were reported to municipalities numbering 326 cases in Dover Township (20 cases more than last year), 55 cases in Dover Borough (6 cases less than last year), 433 cases in Manchester Township (39 cases more than last year), 34 cases in Paradise Township (1 case more than last year), 139 cases in Conewago Township (20 cases less than last year), 93 cases in North York Borough (16 cases more than last year), 40 cases in Franklin Township (12 cases more than last year), and 105 cases in Jackson Township (34 cases more than last year). Our overall Department clearance rate for these crimes is 43.10% compared to 35.52% in 2010. The Statewide clearance average in 2010 was 30.30%. The County average in 2010 was 35.30%.\*

A formula is available to numerically chart or indicate a municipality's crime rate in finite terms. The rate is determined by dividing 100,000 by a municipality's population; times the Part I reported crimes. The overall regional jurisdiction experienced an annual increase (9.22%) in the crime rate. Municipal crime rates appear for review on Table IV.

#### Less Serious Crime

The 2,708 reported crimes, classified as Part II offenses under the FBI Uniform Crime Report System are less serious crimes. Part II Crimes remained the same as 2010. Our overall Department clearance rate for these crimes was 81.06% compared to 80.17% in 2010. The statewide clearance, Part II average in 2010 was 60.7% and the County average was 70.3%.\* Our grand total clearance rate for both Part I and Part II crime was 69.23% compared to 67.03% last year. A three-year review of these crimes appears on Table V. (\*Figures for state and county averages based on the most current UCR Data, which is 2010.)



#### Service Calls

As mentioned earlier, national averages indicate that approximately 80% of all calls received by police will be "service" in nature. We found ours to be 86.03% this year. Municipalities as shown on Table VI received these 28,145 calls.

#### Alarms

Response to alarms is classified as a service call. After several municipal alarm ordinances were revised and fines were increased for false alarms, alarms, by and large, continued to decrease. Again, this year, alarms decreased by 1.03%.

In 2011, total alarm dispatches accounted for 1,735 of the total call load or 6.16%. Last year, alarms accounted for 1,753 of the total call load or 6.53%.

A municipal alarm overview, which compares the number of alarms to the total number of calls in each municipality, finds that we handled 309 or 3.86% in Dover Township, 52 or 4.53% in Dover Borough, 836 or 9.63% in Manchester Township, 41 or 3.26% in Paradise Township, 154 or 4.84% in Conewago Township, 61 or 3.81% in North York Borough, 55 or 4.54% in Franklin Township, and 227 or 7.38% in Jackson Township. The workload generated by alarms in the Support Services Section remains considerable due to the time-consumptive procedures for reporting, invoicing and the associated fiscal record keeping and payments to municipalities in accordance with the revised municipal ordinances.

#### Vehicle Accidents

Accident investigations are also classified within the concept of a service call. We experienced a decrease in the accidents we investigated this year. The 1,757 accidents reflect a decrease of 53 crashes or 2.93% compared to 2010. Injury accidents investigated were 308 and remained the same as 2010. In addition, we investigated 8 fatal accidents (8 deaths) reflecting an increase of 4 or 100%. Alcohol and/or drugrelated fatalities this year totaled 3. (A municipal breakdown of this information is shown on Table VII.)

Over the past 10 years, 69 people were killed in fatal traffic accidents. We continue to seek ways to reduce accidents and save lives using various methods. The enforcement of traffic offenses continues to be of high priority. We hope that our uniformed presence during traffic enforcement will have some deterrent effect on not only the violator, but also the motoring public. We continue to offer educational programs to the public in defensive driving and addressing community concerns with traffic issues. We remain vigilant in reporting dangerous road conditions to both our municipalities and PennDot. Our goal is to continue all of these efforts in an attempt to make our highways safer.

# FIELD SERVICES DIVISION Criminal Investigation Section

The primary responsibility for follow-up investigations of serious crime is vested in the Criminal Investigation Section of the Field Services Division. This section is staffed with a Sergeant who supervises three full-time investigators and an officer temporarily detached from patrol.

The Detective Sergeant is responsible for the review of all criminal reports, supervision at all major crime scenes, staff review of all major criminal cases, liaison with other agencies regarding effective information exchange and coordination of investigative efforts, and preparing the Criminal Investigation Section schedule.

Other duties of the Criminal Investigation Section include:

- Assist the Patrol Division with fatal accident and death investigations
- o Serves as the system manager of the Department's automated evidence management system—this includes tracking, retention, storage, and transportation of evidence for laboratory testing
- Participating in crime prevention and reduction programs, which includes working specialized details in areas where criminal activities are prevalent
- Surveillance and specialized electronic applications
- Perform polygraph examinations
- Investigation and reporting of complex and time intensive investigations, which require follow-up function and dedication of time-based assets
- Liaison and analysis of information between Federal, State, and other local law enforcement agencies

The year 2011 saw the workload remain the same as 2010. There were 2 fewer cases assigned to the Criminal Investigations Division for follow-up investigations. Fortunately, there were no homicides during 2011; however, the unit investigated five (5) cases classified as "Attempted Homicide". Four cases involved the use of firearms and in one case a female was nearly strangled to death. In each of these cases, the offender was charged and is awaiting trial.

The Unit was the recipient of \$60,000 of computer and digital forensic equipment through the York County District Attorney's "Paul Coverdell Forensic Science Improvement Grant". The equipment purchased allows for the analysis of cellular telephones and computers. The Detective

trained in the use of this equipment analyzed 55 computers and 62 cellular phones. Roughly half of this work was provided to other York County Law Enforcement agencies. We expect the demand for this type of specialized training and analysis to grow as more crimes involve electronic media devices.

In 2011, there were 60 interviews conducted at the Children's Advocacy Center (CAC), nearly tripling the 22 interviews conducted in 2010. The CAC is a neutral location used to interview children for all York County child abuse and sexual abuse allegations.

Investigators filed 249 criminal charges compared to 377 in 2010. This included 159 felony complaints compared to 161 in 2010 and 59 misdemeanor complaints compared to 106 in 2010. Another 31 non-traffic summary offenses were filed by criminal investigators during the year. During 2011, investigators consolidated 142 criminal charges with existing charges. The CID unit investigated a total of 1,108 cases, which is two less than the 1,110 cases in 2010. Of the 1,108 cases assigned, the unit cleared 920 or 83.03%. The CID Unit submitted 591 incident reports, 3,821 supplemental reports, conducted 6 polygraph examinations, and catalogued more than 1,600 evidentiary items.

In the paragraphs that follow, the reader is provided a representative overview of the types of cases handled within each municipality by members of the Criminal Investigations Section during 2011:

#### DOVER TOWNSHIP

An 18 year old Dover male is awaiting trial on charges of Criminal Attempt Homicide. The male is accused of manually strangling a female until she was unconscious.

Several suspects were charged with Robbery offenses and await trial. Three men were charged with two separate armed robberies at local convenience stores. Two other men are charged with two robberies that involve pistol-whipping the victims.

#### DOVER BOROUGH

Two suspects are awaiting trail on charges of Criminal Attempt Homicide. They are accused of firing multiple shots from a vehicle on Mayfield Street in an attempt to kill the victim over a drug debt.

## MANCHESTER TOWNSHIP

A York man is awaiting trial on charges of Criminal Attempt Homicide. The male is accused of shooting his wife one time and attempting to shoot her again - execution style - outside their residence. The female survived after the handgun jammed.

A York man awaits trial on Robbery-related charges after he used a weapon to steal a vehicle from a female at a local motel.

Several men are awaiting trial on multiple counts of Burglary. The men are accused of burglarizing more than 100 homes in a three county area. Twelve of the homes were in the Outdoor Country Club.

## PARADISE TOWNSHIP

Two teenage males were charged with Arson-related offenses and several burglaries. The teens are accused of intentionally burning a modular home at a local business.

The investigation of a residential Burglary and Auto Theft continues. The resident's truck and firearm were taken - DNA evidence collected at the scene remains at the Pennsylvania State Police Lab.

# CONEWAGO TOWNSHIP

A Township man is awaiting trial on charges of Aggravated Assault after he stabbed another man multiple times with a pair of scissors.

A Dover man awaits trial on Robbery-related offenses after committing an Armed Robbery at a local grocery store.

A step-father is incarcerated, awaiting trial on charges of molesting his step-daughter. The accused was apprehended in Maryland after he fled Pennsylvania.

# NORTH YORK BOROUGH

A Borough man is awaiting trial on charges of Criminal Attempt Homicide after he shot his father during a domestic dispute that also involved a knife.

A Dover man is charged with an Armed Robbery at the Dunkin Donuts and awaits trial.

A York City man is charged with multiple Burglaries and Auto Thefts from the Borough.

## FRANKLIN TOWNSHIP

A registered sex offender awaits trial on several sex offenses after luring teenaged girls to meet him in the Township.

Two suspects were charged with burglarizing a home in the Township. While inside the residence, they stole checks and passed the stolen checks at a local hardware store.


# JACKSON TOWNSHIP

A Township male is charged with Criminal Attempt Homicide after he fired more than 30 rounds into the adjacent neighbor's home. This was in response to loud music complaints. The male then barricaded himself inside the home and the York County Quick Response Team responded to assist with the apprehension.


A Township resident was arrested for repeatedly raping his teenage daughters for over a period of several years.


Total Department Criminal Arrests

# Community Police Unit

The "Community Police Unit" presented a total of 68 programs in 2011, reaching out to over 6,720 people. Of these, 38 programs were presented to our local schools and more than 3,200 students were addressed through a variety of assemblies and in-class seminars. These programs ranged from personal safety issues to drug awareness. Also, the CPO Unit hosted 30 civic programs with 1,075 persons in attendance. There were 25 child car seat checks completed by our certified car seat technician.

During 2011, the Department participated in the Drug Enforcement Administration's (DEA) National Drug Take-Back Days. Research has shown that many Americans simply do not know how to properly dispose of their unused or expired prescription medications. This program offers the public a convenient and safe way in which to dispose of these medications. On two occasions during the year, an officer was posted to an established collection point at the Giant Food Store in Dover Township. Citizens were able to deposit the medications into a receptacle. The officer later turned-over the medications to a DEA representative for appropriate disposal. The National Drug Take-Back Days collected 150 pounds of unused or expired medications. The Department intends to continue participation in this program in the future.

In addition, the Unit has also been involved with community concerns and activities with everything from problems with traffic flow and speeding motorists to the coordinating of benefit runs, parades, and block watch events. The Community Police Officer (CPO) instructed one class in "Defensive Driving" involving 20 participants, age 16 and older. Throughout the history of the classes, the CPO unit has taught over 578 "students" this defensive driving program.

"Officer Dorothy" was utilized in 17 programs at the schools and at local civic events with more than 2,445 people attending. Several donations were received throughout the year for the "Officer Dorothy" Program, totaling \$776.00.

# School Resource Officer (SRO)

Since 2008, the NYCRPD has been providing a School Resource Officer to the Spring Grove Area School District. The SRO, based at the high school, works 1,560 hours annually. The SRO is responsible for all law enforcement related issues at all district facilities with the exception of York New Salem Elementary School and the District Administration Building. This program has been well received and has generated many positive student/officer relationships. The SRO also provides many educational programs to students in the district as well as coordinating all security issues for school-related events.

During 2011, 318 incidents were handled. This is 65 more than 2010. Of the 318 incidents, 215 or 67.6% were at the high school, 49 or 15.4% were at the middle school, 11 or 3.46% were at the intermediate school, 13 or 4.1% were at the elementary schools, and 30 or 9.4% of the incidents related to security at school events.

### SUPPORT SERVICES DIVISION

# Records Section

The primary responsibility for gathering, compiling, and disseminating information lies with the Records Section. A Corporal (who supervises the civilians) and four civilian employees staff this section. The role of the Records Section is to insure and coordinate the rapid and orderly flow of information between the various components of the police department. One of the many integral functions is to provide data entry into the automated information system. The members also provide other varied services, including the greeting of all visitors to departmental headquarters and processing all insurance or other outside requests for information. The staff assigned to Records processed nearly one million records in 2011.


The information from the automated database continues to be vital in many tasks essential to department effectiveness and efficiency. These tasks include identification of crime patterns and trends, providing information to assist in the scheduling and distribution of manpower and the cohesive exchange of information with other agencies for the solution of crime.

# Court Disposition Report

During 2011, 2,259 defendants exercised their constitutional option to a hearing at the District Court level. This is a 14.83% increase from 2010. Of the 2,259 hearings, 1,980 or 87.65% were found guilty in summary (traffic and non-traffic) cases. At the York County Court of Common Pleas, 143 defendants appeared which is an increase of 8.33% from 2010. Of the 143 cases, 124 or 86.71% were convicted. The 143 cases represented felony and misdemeanor charges as well as Summary Appeals and Indirect Criminal Contempt of Court cases.

Of all court cases during 2011, 71.35% were held while the officer was on duty. Patrol officers had court appearances on duty 70.85% of the time and criminal investigators were on duty 100% of the time.

Total County Court Trials/Hearings = 143







CHART VI

# Pennsylvania's Right to Know Law (Act 3 of 2008)

An added responsibility was placed on the Support Services Supervisor in the last two years that has become very time consuming. The "Right to Know" law required an "Open Records Compliance Officer" (ORCO), which currently is the supervisor of Support Services.

Throughout the year, there are many requests for documents by the public and other entities. These requests are handled by the ORCO. The process to respond to the requests is as follows:

- o Department receives written request for document
- o Document is researched and located
- o Document is reviewed to determine what information can be released
- o Redact all information that must be excluded
- o Provide a written response to the requestor
- o Maintain a written log of all requests and actions taken

In 2010, we processed 126 requests and 141 in 2011.

### TRAINING REPORT

The Department continues to place strong emphasis on training. The philosophy of the Department being that mandated training is a minimum standard, not a maximum. The Department strives to avail all its members, both sworn and non-sworn, the opportunity to receive as much training as scheduling and budget permits. In addition to the annual training mandated by MPOETC, the Department affords both sworn and non-sworn staff the opportunity to attend a vast array of training in numerous functional areas. To that end, we were able to offer 4500 hours of training during 2011.

### VEHICLE DAMAGE

### AT-FAULT ACCIDENTS

During 2011, the Department experienced a total of four (4) accidents in which the officer was culpable. The monetary loss due to these accidents was \$21,403.80. This includes the accident involving Officer Groff, which accounted for \$20,808.00 in damage. Each of the responsible officers received disciplinary action for their negligence. Though four at-fault accidents are by no means acceptable, our overall safety record was good considering that the officers traveled 149,151 miles for every at-fault accident. Considering that the officers drive in every conceivable type of weather, often times in an emergency response mode, the number of accidents remains extremely low.

### PRISONER DAMAGE

Occasionally, suspects who are in custody and secured within a patrol vehicle, intentionally inflict damage to the vehicle. Most often this results from suspects kicking the interior door panels or windows. During 2011, unruly suspects caused a total of \$2,651.31 in damage to patrol vehicles. In each case the offender was criminally charged for damaging the vehicle and restitution requested through the court system.

In early 2010, we recognized the need to improve upon our Department website. Our goal was to create a user-friendly site that could be used by the community, media, law enforcement, and others as a means to provide accurate and timely information.

The website provides easily accessible ways to contact the Department. Visitors can provide information to specific units such as traffic, criminal, and community policing. Department forms commonly requested by the public are printable from the website.

In 2011, <a href="www.nycrpd.org">www.nycrpd.org</a> averaged 686 visitors a day, totaling more than 250,000 for the year. Since the new website was launched on April 23, 2010, more than 375,000 visitors have used our site. The project has been a huge success and additional enhancements will occur in 2012.

### CONCLUSION

In 2011, we handled 28,145 calls, 1,318 more than 2010 for a 4.91% increase. Seven municipalities increased and one decreased. The most dramatic increase is Paradise Township and the most dramatic decrease is North York Borough. A breakdown of our overall jurisdiction and individual municipal activity appears on Table VIII.
