MINUTES OF THE BOARD OF COMMISSIONERS MEETING**

August 18, 2020

Chairperson Wilhide called the meeting to order at 7:00 p.m. In attendance were Commissioners Andrew Kroft, Michael Cashman, Rodney Brandstedter, Clark Craumer, Nancy Brunk, David Brown, Dennis Luckenbaugh, Matthew Bollinger, Solicitor Rudolf, Diane Wales, and Chief Lash. Commissioners Matthew Muir and Mark Wenrich were absent.

After the Pledge of Allegiance, public comment was requested. There was no public comment.

The minutes of the July 21, 2020 meeting were presented. A motion was made by David Brown, second by Michael Cashman, and the motion carried to accept the July minutes.

The Financial Report, which includes earned interest, deposits, and withdrawals (checks written and EFT transactions), made to the Fulton Bank Checking Accounts, the Dorothy Kling Fund, and the Health Insurance Fund, was presented for approval. The Board accepted this report on a motion by Dennis Luckenbaugh, second by Andrew Kroft and unanimously carried.

The Chief's Report was presented to the Board. A copy of this report is attached. This report was accepted on a motion by Clark Craumer, second by Michael Cashman, and unanimously carried.

On a motion by Dennis Luckenbaugh and second by Rodney Brandstedter, and unanimously carried, the Board approved the project with costs not to exceed \$10,000, plus 10% of project total from the Capital Improvement Fund. Construction to begin as soon as possible for completion prior to the building dedication on October 21, 2020.

Six of the legacy municipalities experienced a decrease in calls for police service in July 2020 compared to July 2019. Those municipalities are Dover, Conewago, Franklin and Jackson Township as well as Dover and North York Borough. Two legacy municipalities experienced an increase in calls for service. Those municipalities are Manchester and Paradise Township. Current baseline data for July 2019 for North Codorus, Manheim and Heidelberg Township was not available.

In the area of traffic law enforcement, the following occurred during the month of July 2020 when compared to the month of July 2019:

- Traffic citations were up from 988 to 1032
- Warning cards were down from 220 to 122
- Parking tickets were down from 16 to 3

Patrols conducted over 1,300 self-initiated traffic investigations during the month of July 2020. Not included in that figure are the 15 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .162 by volume, the lowest BAC being .088 and the highest BAC being .317 by volume.

The traffic accident summary reveals the following:

July 2019 there were 21 injury accidents
July 2020 there were 24 injury accidents

July 2019 there were 25 persons injured in traffic accidents
July 2020 there were 24 persons injured in traffic accidents

July 2019 there were a total of 141 accidents
July 2020 there were a total of 146 accidents

During July 2020, Patrol and CID arrested 164 criminal defendants which is 3 less criminal arrests than July 2019. Of the 164 arrests, 22 were felonies, 61 were misdemeanors, and 81 were summary offenses.
