July 21, 2020

Chairperson Wilhide called the meeting to order at 7:00 p.m. In personal attendance were Commissioners Andrew Kroft, Michael Cashman, Rodney Brandstedter, Clark Craumer, Nancy Brunk, Mark Wenrich, David Brown, Dennis Luckenbaugh, Matthew Muir, Solicitor Rudolf, Diane Wales, and Chief Lash. Commissioners Matthew Bollinger was absent.

After the Pledge of Allegiance, public comment was requested. There was no public comment.

The minutes of the June 16, 2020 meeting were presented. A motion was made by Andrew Kroft, second by Michael Cashman, and the motion carried to accept the June minutes.

The Financial Report, which includes earned interest, deposits, and withdrawals (checks written and EFT transactions), made to the Fulton Bank Checking Accounts, the Dorothy Kling Fund, and the Health Insurance Fund, was presented for approval. The Board accepted this report on a motion by Dennis Luckenbaugh, second by Clark Craumer and unanimously carried.

Resolution 04-2020: The Commission adopted Resolution 04-2020 to execute the Intergovernmental Cooperative Agreement between the Northern York County Regional Police Department, Southwestern Regional Police Board, North Codorus Township, Manheim Township, Heidelberg Township and Spring Grove Borough on a motion by Rodney Brandstedter, second by Michael Cashman and carried on an 8-1 vote. Manchester Township voted no for the Resolution approval.

Appreciation Gift to Officers: On a motion by Andrew Kroft, second by Michael Cashman and unanimously carried, the Commission agreed to spend up to \$3,500 from the donation account to purchase an appreciation gift for each officer.

Five of the legacy municipalities experienced a decrease in calls for police service in June 2020 compared to June 2019. Those municipalities are Dover, Conewago, Franklin and Jackson Township as well as North York Borough. Three legacy municipalities experienced an increase in calls for service. Those municipalities are Manchester and Paradise Township as well as Dover Borough. Current baseline data for June 2019 for North Codorus, Manheim and Heidelberg Township was not available. In the area of traffic law enforcement, the following occurred during the month of June 2020 when compared to the month of June 2019:

- Traffic citations were up from 1057 to 1228
- Warning cards were up from 198 to 274
- Parking tickets were down from 10 to 5

Patrols conducted over 1,600 self-initiated traffic investigations during the month of June 2020. Not included in that figure are the 16 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .157 by volume, the lowest BAC being .110 and the highest BAC being .203 by volume.

The traffic accident summary reveals the following:

June 2019 there were 20 injury accidents
June 2020 there were 20 injury accidents

June 2019 there were 26 persons injured in traffic accidents
June 2020 there were 25 persons injured in traffic accidents

June 2019 there were a total of 119 accidents
June 2020 there were a total of 138 accidents

During June 2020, Patrol and CID arrested 207 criminal defendants which is 40 more criminal arrests than June 2019. Of the 207 arrests, 27 were felonies, 91 were misdemeanors, and 87 were summary offenses.
