MINUTES OF THE BOARD OF COMMISSIONERS MEETING**

January 19, 2021

Chief Lash called the meeting to order at 6:59 p.m. In attendance were Commissioners Michael Cashman, Andrew Kroft, Rodney Brandstedter, Lorreta Wilhide, Nancy Brunk, Mark Wenrich, David Brown, Dennis Luckenbaugh, Larry Miller and Matthew Bollinger, Solicitor Rudolf, Diane Wales and Chief Lash. Clark Craumer from Paradise Township was absent.

After the Pledge of Allegiance, public comment was requested. There was no public comment.

The meeting began with the promotion of six (6) Explorers to the rank of Corporal. Lorreta Wilhide administered the oath of office.

After the Pledge of Allegiance, the Board reorganization began. On a motion by David Brown, second by Dennis Luckenbaugh, and unanimously carried, Lorreta Wilhide was elected to the position of Chairman. At this point, the meeting was turned over to Chairperson Wilhide to continue the reorganization. On a motion by Rodney Brandstedter, second by David Brown, and unanimously carried, Michael Cashman was elected as the Vice Chairperson. On a motion by Michael Cashman, second by Mark Wenrich, and unanimously carried, Andrew Kroft was elected to the Secretary position. On a motion by Andrew Kroft, second by David Brown, and unanimously carried, Clark Craumer was elected to the Treasurer position.

The following committee appointments were also completed:

Collective Bargaining – Rodney Brandstedter and David Brown
Pension Board – Matthew Bollinger and Clark Craumer
Award Review Board – Michael Cashman and Dennis Luckenbaugh

The minutes of the November 17, 2020 meeting were presented. A motion was made by Andrew Kroft, second by David Brown, and unanimously carried to accept the November minutes.

The Financial Reports December 2020 and January 2021, which includes earned interest, deposits, and withdrawals (checks written and EFT transactions), made to the Fulton Bank Checking Accounts, the Dorothy Kling Fund, and the Health Insurance Fund, were presented for approval. The Board accepted this report on a motion by Dennis Luckenbaugh, second by Rodney Brandstedter and unanimously carried.

The Chief's Report for December 2020 and January 2021 was presented to the Board. Copies of these reports are attached. These reports were accepted on a motion by Michael Cashman, second by David Brown, and unanimously carried.

Swearing in of New Officers: Chairperson Wilhide administered the oath of office to new hires Courtney Herring and Adam Eisenhart.

Permanent Appointment to Police Officer: Chief Lash recommended Aaron Witmoyer and Kyle Forry be permanently appointed to the rank of Patrol Officer, effective January 10, 2021. On a motion by David Brown, second by Rodney Brandstedter and unanimously carried the recommendation was accepted.

WRAP Reality Project: After a brief discussion led by Chief Lash, on a motion by Rodney Brandstedter and second by Mark Wenrich, the Commission unanimously agreed to authorize the Chief to initiate the leasing acquisition and authorize funding from the Technology Sinking Fund should funding from private foundations and donations not cover the costs associated with the WRAP Reality Project.

Spring Grove EMS Lease: On a motion by Andrew Kroft, second by Rodney Brandstedter and unanimously carried, the Board agreed to sign the five year lease allowing Spring Grove EMS to become a tenant at the Northern York County Regional Police Department Substation locate at 6115 Thoman Drive, Spring Grove PA, 17362.

On a motion by Andrew Kroft, Chairperson Wilhide adjourned the meeting at 8:23 pm.

Five of the legacy municipalities experienced a decrease in calls for police service in December 2020 compared to December 2019. Those municipalities are Manchester, Paradise, Conewago Township as well as Dover and North York Borough. Three of the legacy municipalities experienced an increase in calls for police service. Those municipalities are Dover, Franklin and Jackson Township. Current baseline data for December 2019 for North Codorus, Manheim and Heidelberg Township was not available.

In the area of traffic law enforcement, the following occurred during the month of December 2020 when compared to the month of December 2019:

- Traffic citations were up from 779 to 972
- Warning cards were down from 247 to 231
- Parking tickets were down from 9 to 7

Patrols conducted over 1,300 self-initiated traffic investigations during the month of December 2020. Not included in that figure are the 4 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .188 by volume, the lowest BAC being .090 and the highest BAC being .243 by volume.

The traffic accident summary reveals the following:

December 2019 there were 21 people injured
December 2020 there were 18 people injured

December 2019 there were a total of 178 accidents
December 2020 there were a total of 185 accidents

During December 2020, Patrol and CID arrested 141 criminal defendants which is 40 less criminal arrests than December 2019. Of the 141 arrests, 23 were felonies, 61 were misdemeanors, and 57 were summary offenses.

Six of the legacy municipalities experienced a decrease in calls for police service in November 2020 compared to November 2019. Those municipalities are Manchester, Paradise, Conewago, and Jackson Township as well as Dover and North York Borough. Dover Township experienced an increase in calls for police service and Franklin Township remained unchanged. Current baseline data for November 2019 for North Codorus, Manheim and Heidelberg Township was not available.

In the area of traffic law enforcement, the following occurred during the month of November 2020 when compared to the month of November 2019:

- Traffic citations were up from 899 to 1004
- Warning cards were down from 213 to 151
- Parking tickets were up from 3 to 8

Patrols conducted over 1,200 self-initiated traffic investigations during the month of November 2020. Not included in that figure are the 17 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .127 by volume, the lowest BAC being .100 and the highest BAC being .155 by volume.

The traffic accident summary reveals the following:

November 2019 there were 30 people injured
November 2020 there were 18 people injured

November 2019 there were a total of 156 accidents
November 2020 there were a total of 149 accidents

During November 2020, Patrol and CID arrested 180 criminal defendants which is 6 less criminal arrests than November 2019. Of the 180 arrests, 20 were felonies, 92 were misdemeanors, and 68 were summary offenses.
