
NEW BUSINESS

Six of the municipalities experienced an increase in calls for police service in December 2021 compared to December 2020. Those municipalities are Dover, Manheim, North Codorus, Paradise Township as well as Dover and North York Borough. Five municipalities experienced a decrease in calls for police service in December 2021 compared to December 2020. Those municipalities are Conewago, Franklin, Heidelberg, Jackson and Manchester Township.

In the area of traffic law enforcement, the following occurred during the month of December 2021 when compared to the month of December 2020:

Traffic citations were up from 972 to 1132 +160
Warning cards/faulty equipment cards were up from 231 to 307 +76
Parking tickets remained unchanged at 7

Proudly Serving:

Patrols conducted over 1,400 self-initiated traffic investigations during the month of December 2021. Not included in that figure are the 20 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .164 by volume, the lowest BAC being .027 and the highest BAC being .248 by volume.

The traffic accident summary reveals the following:

December 2020 there were 18 people injured December 2021 there were 31 people injured

December 2020 there were 16 injury accidents December 2021 there were 24 injury accidents

December 2020 there were a total of 189 accidents December 2021 there were a total of 166 accidents

During December 2021, Patrol and CID arrested 224 criminal defendants which is 83 more criminal arrests than December 2020. Of the 224 arrests, 29 were felonies, 106 were misdemeanors, and 89 were summary offenses.
