**March 15, 2022**

Chairperson Wilhide called the meeting to order at 7:00 p.m. In attendance were Commissioners Andrew Kroft, Michael Cashman, David Brown, Rodney Brandstedter, Dennis Luckenbaugh, Nancy Brunk, Clark Craumer, Solicitor Rudolf, Diane Wales and Chief Lash. Commissioners Mark Wenrich, Matthew Bollinger and Larry Miller were absent.

After the Pledge of Allegiance, public comment was requested.

The minutes of the February 15, 2022 meeting were presented. A motion was made by Andrew Kroft, second by Dennis Luckenbaugh, and carried to accept the February minutes. Michael Cashman abstained from voting due to his absence at the February meeting.

The Financial Report for March 2022, which includes earned interest, deposits, and withdrawals (checks written and EFT transactions), made to the Fulton Bank Checking Accounts, the Dorothy Kling Fund, and the Health Insurance Fund, was presented for approval. Seven of the municipalities experienced an increase in calls for police service in February 2022 compared to February 2021. Those municipalities are Conewago, Dover, Heidelberg, Jackson, Manchester, and Manheim Township as well as Dover Borough. Four municipalities experienced a decrease in calls for police service in February 2022 compared to February 2021. Those municipalities are Franklin, North Codorus and Paradise Township as well as North York Borough.

In the area of traffic law enforcement, the following occurred during the month of February 2022 when compared to the month of February 2021:

Traffic citations were down from 1460 to 1042      -418  
Warning cards/faulty equipment cards were down from 368 to 308      -60  
Parking tickets were down from 55 to 2      -53

Patrols conducted over 1,300 self-initiated traffic investigations during the month of February 2022. Not included in that figure are the 17 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .138 by volume, the lowest BAC being .090 and the highest BAC being .257 by volume.

The traffic accident summary reveals the following:

February 2021 there were 16 people injured  
February 2022 there were 16 people injured

February 2021 there were 11 injury accidents  
February 2022 there were 14 injury accidents

February 2021 there were a total of 138 accidents  
February 2022 there were a total of 142 accidents

During February 2022, Patrol and CID arrested 176 criminal defendants which is 5 less criminal arrests than February 2021. Of the 176 arrests, 35 were felonies, 104 were misdemeanors, and 37 were summary offenses.
