MINUTES OF THE BOARD OF COMMISSIONERS MEETING**

April 19, 2022

Chairperson Wilhide called the meeting to order at 6:58 p.m. In attendance were Commissioners Andrew Kroft, Michael Cashman, Mark Wenrich, Matthew Bollinger, David Brown, Rodney Brandstedter, Larry Miller, Dennis Luckenbaugh, Nancy Brunk, Clark Craumer, Diane Wales and Chief Lash. Solicitor Rudolf was absent.

After the Pledge of Allegiance, public comment was requested.

The minutes of the March 15, 2022 meeting were presented. A motion was made by Dennis Luckenbaugh, second by David Brown, and carried 8-0 to accept the March minutes. Matthew Bollinger and Larry Miller abstained from voting due to their absence at the March meeting.

The Financial Report for April 2022, which includes earned interest, deposits, and withdrawals (checks written and EFT transactions), made to the Fulton Bank Checking Accounts, the Dorothy Kling Fund, and the Health Insurance Fund, was presented for approval. Seven of the municipalities experienced an increase in calls for police service in March 2022 compared to March 2021. Those municipalities are Conewago, Heidelberg, Manheim, North Codorus and Paradise Township as well as Dover and North York Borough. Four municipalities experienced a decrease in calls for police service in March 2022 compared to March 2021. Those municipalities are Dover, Franklin, Jackson and Manchester Township.

In the area of traffic law enforcement, the following occurred during the month of March 2022 when compared to the month of March 2021:

Traffic citations were down from 1793 to 1067 -726
Warning cards/faulty equipment cards were down from 370 to 321 -49
Parking tickets were up from 3 to 18 +15

Patrols conducted over 1,400 self-initiated traffic investigations during the month of March 2022. Not included in that figure are the 31 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .181 by volume, the lowest BAC being .092 and the highest BAC being .296 by volume.

The traffic accident summary reveals the following:

March 2021 there were 30 people injured
March 2022 there were 18 people injured

March 2021 there were 24 injury accidents
March 2022 there were 12 injury accidents

March 2021 there were a total of 153 accidents
March 2022 there were a total of 145 accidents

During March 2022, Patrol and CID arrested 183 criminal defendants which is 37 less criminal arrests than March 2021. Of the 183 arrests, 23 were felonies, 90 were misdemeanors, and 23 were summary offenses.
