MINUTES OF THE BOARD OF COMMISSIONERS
MEETING**

August 16, 2022

Chairperson Wilhide called the meeting to order at 6:01 p.m. In attendance were Commissioners Andrew Kroft, Michael Cashman, Matthew Bollinger, Dave Brown, Rodney Brandstedter, Larry Miller, Dennis Luckenbaugh, Nancy Brunk, Clark Craumer, Diane Wales and Chief Lash. Solicitor Rudolf was present. Commissioner Mark Wenrich from Franklin Township was absent. Alternate Commissioner Beth Brennan from Manchester Township was present.

After the Pledge of Allegiance, public comment was requested.

Chairperson Wilhide announced that a special Executive Session to discuss real estate and litigation was held on Thursday, August 4, 2022.

The minutes of the July 19, 2022, meeting were presented. A motion was made by Dennis Luckenbaugh, second by Andrew Kroft, and unanimously carried to accept the July minutes.

The Financial Report for July 2022, which includes earned interest, deposits, and withdrawals (checks written and EFT transactions), made to the Fulton Bank Checking Accounts, the Dorothy Kling Fund, and the Health Insurance Fund, was presented for approval. The Board accepted this report on a motion by Clark Craumer, second by Nancy Brunk and unanimously carried.

The Chiefs Report for July 2022 was presented to the Board. A copy of this report is attached. The report was accepted on a motion by David Brown, second by Michael Cashman, and unanimously carried.

Permanent Appointment to Police Officer: Chief Lash recommended Jack Govern be permanently appointed to the rank of Patrol Officer, effective September 17, 2022. On a motion by Andrew Kroft, second by Rodney Brandstedter and unanimously carried the recommendation was accepted.

Nine of the municipalities experienced a decrease in calls for police service in July 2022 compared to July 2021. Those municipalities are Dover, Franklin, Heidelberg, Jackson, Manchester, Manheim and Paradise Township as well as Dover and North York Borough. Two of the municipalities experienced a decrease in calls for police service in July 2022 compared to July 2021. Those municipalities are Conewago and North Codorus Township.

In the area of traffic law enforcement, the following occurred during the month of July 2022 when compared to the month of July 2021:

Traffic citations were up from 1159 to 1217 +58
Warning cards/faulty equipment cards were up from 238 to 313 +133
Parking tickets were up from 2 to 11 +9

Patrols conducted over 1,500 self-initiated traffic investigations during the month of July 2022. Not included in that figure are the 27 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .187 by volume, the lowest BAC being .103 and the highest BAC being .388 by volume.

The traffic accident summary reveals the following:

July 2021 there were 32 people injured
July 2022 there were 26 people injured

July 2021 there were 25 injury accidents
July 2022 there were 21 injury accidents

July 2021 there were a total of 156 accidents
July 2022 there were a total of 130 accidents

During July 2022, Patrol and CID arrested 210 criminal defendants which is 3 less criminal arrests than July 2021. Of the 210 arrests, 35 were felonies, 105 were misdemeanors, and 70 were summary offenses.
