Seven of the municipalities experienced a increase in calls for police service in October 2022 compared to October 2021. Those municipalities are Conewago, Dover, Jackson, Manchester, North Codorus and Paradise Township as well as Dover Borough. Four of the municipalities experienced a decrease in calls for police service in October 2022 compared to October 2021. Those municipalities are Franklin, Heidelberg, and Manheim Township as well as North York Borough.

In the area of traffic law enforcement, the following occurred during the month of October 2022 when compared to the month of October 2021:

Traffic citations were down from 1118 to 867 -251
Warning cards/faulty equipment cards were down from 336 to 307 -29
Parking tickets were unchanged at 7

Patrols conducted over 1,100 self-initiated traffic investigations during the month of October 2022. Not included in that figure are the 34 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .149 by volume, the lowest BAC being .081 and the highest BAC being .349 by volume.

The traffic accident summary reveals the following:

October 2021 there were 23 people injured
October 2022 there were 37 people injured

October 2021 there were 20 injury accidents
October 2022 there were 25 injury accidents

October 2021 there were a total of 200 accidents
October 2022 there were a total of 160 accidents

During October 2022, Patrol and CID arrested 223 criminal defendants which is 21 more criminal arrests than October 2021. Of the 223 arrests, 41 were felonies, 97 were misdemeanors, and 85 were summary offenses.
