# NYCRP MINUTES OF THE BOARD OF COMMISSIONERS MEETING

## January 17, 2023

Solicitor's Report - No report given.



Eight of the municipalities experienced an increase in calls for police service in December 2022 compared to December 2021. Those municipalities are Conewago, Dover, Franklin, Heidelberg, Jackson, Manchester, Manheim Township, as well as Dover Borough. Three municipalities experienced a decrease in calls for police service in December 2022 compared to December 2021. Those municipalities are North Codorus and Paradise Township as well as North York Borough.

In the area of traffic law enforcement, the following occurred during the month of December 2022 when compared to the month of December 2021:

Traffic citations were down from 1132 to 948 -184Warning cards/faulty equipment cards were up from 307 to 349 +42Parking tickets were up from 7 to 13 +6

## Proudly Serving:

Patrols conducted over 1,400 self-initiated traffic investigations during the month of December 2022. Not included in that figure are the 35 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .159 by volume, the lowest BAC being .045 and the highest BAC being .302 by volume.

The traffic accident summary reveals the following:

December 2021 there were 31 people injured December 2022 there were 22 people injured

December 2021 there were 24 injury accidents December 2022 there were 18 injury accidents

December 2021 there were a total of 166 accidents December 2022 there were a total of 149 accidents

During December 2022, Patrol and CID arrested 212 criminal defendants which is 12 less criminal arrests than December 2021. Of the 212 arrests, 32 were felonies, 118 were misdemeanors, and 62 were summary offenses.
