Ten of the municipalities experienced an increase in calls for police service in November 2022 compared to November 2021. Those municipalities are Conewago, Dover, Franklin, Heidelberg, Jackson, Manchester, Manheim, North Codorus and Paradise Township as well as Dover Borough. One municipality, North York Borough, experienced a decrease in calls for police service in November 2022 compared to November 2021.

In the area of traffic law enforcement, the following occurred during the month of November 2022 when compared to the month of November 2021:

Traffic citations were down from 1108 to 894 -214
Warning cards/faulty equipment cards were down from 283 to 261 -22
Parking tickets were up from 6 to 9 +3

Patrols conducted over 1,100 self-initiated traffic investigations during the month of November 2022. Not included in that figure are the 29 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .151 by volume, the lowest BAC being .087 and the highest BAC being .232 by volume.

The traffic accident summary reveals the following:

November 2021 there were 31 people injured
November 2022 there were 41 people injured

November 2021 there were 24 injury accidents
November 2022 there were 30 injury accidents

November 2021 there were a total of 146 accidents
November 2022 there were a total of 188 accidents

During November 2022, Patrol and CID arrested 184 criminal defendants which is 23 more criminal arrests than November 2021. Of the 184 arrests, 21 were felonies, 85 were misdemeanors, and 78 were summary offenses.
