Six of the municipalities experienced an increase in calls for police service in August 2023 compared to August 2022. Those municipalities are Conewago, Jackson, Manchester, Manheim and Paradise Twp as well as North York Borough. Four municipalities experienced a decrease in calls for service Dover, Franklin and North Codorus Township as well as Dover Borough. Heidelberg Township remained unchanged from August 2022.

In the area of traffic law enforcement, the following occurred during the month of August 2023 when compared to the month of August 2022:

Traffic citations were down from 998 to 688 -310
Warning cards/faulty equipment cards were down from 317 to 302 -15
Parking tickets were down from 22 to 11 -11

Proudly Serving:

Patrols conducted over 1,000 self-initiated traffic investigations during the month of August 2023. Not included in that figure are the 16 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .147 by volume, the lowest BAC being .055 and the highest BAC being .276 by volume.

The traffic accident summary reveals the following:

August 2022 there were 21 people injured August 2023 there were 38 people injured

August 2022 there were 20 injury accidents August 2023 there were 27 injury accidents

August 2022 there were a total of 153 accidents August 2023 there were a total of 149 accidents

During August 2023, Patrol and CID arrested 201 criminal defendants which is 34 more criminal arrests than August 2022. Of the 201 arrests, 21 were felonies, 114 were misdemeanors, and 66 were summary offenses.
