November 21, 2023

Chairperson Wilhide called the meeting to order at 6:00 p.m. In attendance were Commissioners Andrew Kroft, Michael Cashman, Mark Wenrich, Matthew Bollinger, Dave Brown, Rodney Brandstedter, Rose Kirkpatrick, Dennis Luckenbaugh, Nancy Brunk, Clark Craumer, Heather Billet and Chief Lash. Solicitor Rudolf was absent.

After the Pledge of Allegiance, public comment was requested.

The minutes of the October 17, 2023, meeting were presented. A motion was made by Dave Brown, second by Nancy Brunk, and carried 10-0 to accept the October minutes. Matthew Bollinger abstained.

The Financial Report for October 2023, which includes earned interest, deposits, and withdrawals (checks written and EFT transactions), made to the Fulton Bank Checking Accounts, the Dorothy Kling Fund, and the Health Insurance Fund, was presented for approval. The Board accepted this report on a motion by Dave Brown, second by Clark Craumer and unanimously carried.

FLIR Thermal Monoculars: Chief Lash requests the purchase of three (3) FLIR Thermal Monoculars to be paid from the Technology Fund in the amount of \$12,466.98, which includes mounting to vehicles. The request was approved on a motion by Michael Cashman, second by Dennis Luckenbaugh and unanimously carried.

Executive Session: On a motion by Clark Craumer, the Commission entered an Executive Session at 6:38pm to discuss personnel matters. On a motion by Michael Cashman, the Board reconvened from Executive Session at 6:48pm.

Eight of the municipalities experienced an increase in calls for police service in October 2023 compared to October 2022. Those municipalities are Conewago, Franklin, Heidelberg, Jackson, Manchester, Manheim and North Codorus Township as well as North York Borough. Three municipalities experienced a decrease in calls for service Dover and Paradise Township as well as Dover Borough.

In the area of traffic law enforcement, the following occurred during the month of October 2023 when compared to the month of October 2022:

Traffic citations were down from 867 to 704 -163
Warning cards/faulty equipment cards were down from 307 to 233 -74
Parking tickets were up from 7 to 15 +8

Patrols conducted over 1,000 self-initiated traffic investigations during the month of October 2023. Not included in that figure are the 13 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .132 by volume, the lowest BAC being .052 and the highest BAC being .205 by volume.

The traffic accident summary reveals the following:

October 2022 there were 37 people injured
October 2023 there were 39 people injured

October 2022 there were 25 injury accidents
October 2023 there were 29 injury accidents

October 2022 there were a total of 160 accidents
October 2023 there were a total of 205 accidents

During October 2023, Patrol and CID arrested 189 criminal defendants which is 34 less criminal arrests than October 2022. Of the 189 arrests, 25 were felonies, 92 were misdemeanors, and 72 were summary offenses.
