Six of the municipalities experienced a decrease in calls for police service in November 2023 compared to November 2022. Those municipalities are Dover, Heidelberg, Manchester, Manheim North Codorus Township as well as Dover Borough. Five municipalities experienced an increase in calls for service. Those municipalities are Conewago, Franklin, Jackson and Paradise Township as well as North York Borough.

In the area of traffic law enforcement, the following occurred during the month of November 2023 when compared to the month of November 2022:

Traffic citations were up from 894 to 939 +45
Warning cards/faulty equipment cards were up from 261 to 320 +59
Parking tickets were down from 9 to 3 -6

Patrols conducted over 1,200 self-initiated traffic investigations during the month of November 2023. Not included in that figure are the 20 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .169 by volume, the lowest BAC being .115 and the highest BAC being .250 by volume.

The traffic accident summary reveals the following:

November 2022 there were 41 people injured
November 2023 there were 36 people injured

November 2022 there were 30 injury accidents
November 2023 there were 28 injury accidents

November 2022 there were a total of 188 accidents
November 2023 there were a total of 175 accidents

During November 2023, Patrol and CID arrested 164 criminal defendants which is 20 less criminal arrests than November 2022. Of the 164 arrests, 14 were felonies, 82 were misdemeanors, and 68 were summary offenses.
