Nine of the municipalities experienced a decrease in calls for police service in December 2023 compared to December 2022. Those municipalities are Conewago, Dover, Franklin, Heidelberg, Manheim, North Codorus, and Paradise Township as well as Dover and North York Borough. Two municipalities, Jackson and Manchester Township, experienced an increase in calls for service.

In the area of traffic law enforcement, the following occurred during the month of December 2023 when compared to the month of December 2022:

Traffic citations were down from 948 to 937 -11
Warning cards/faulty equipment cards were up from 349 to 353
Parking tickets were up from 13 to 14

Patrols conducted over 1,200 self-initiated traffic investigations during the month of December 2023. Not included in that figure are the 25 drivers arrested for Driving Under the Influence (DUI) of Drugs/Alcohol. The average BAC was .152 by volume, the lowest BAC being .048 and the highest BAC being .271 by volume.

The traffic accident summary reveals the following:

December 2022 there were 22 people injured December 2023 there were 26 people injured

December 2022 there were 18 injury accidents December 2023 there were 19 injury accidents

December 2022 there were a total of 149 accidents December 2023 there were a total of 205 accidents

During December 2023, Patrol and CID arrested 201 criminal defendants which is 11 less criminal arrests than December 2022. Of the 201 arrests, 37 were felonies, 104 were misdemeanors, and 60 were summary offenses.
